

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sif-Oidak District Economic Development Budget in the amount
of \$150,000)**

RESOLUTION NO. 12-353

1 **WHEREAS, the Sif-Oidak District Council, on August 14, 2012, passed Resolution No. SODC 12-051,**
2 **“Creating a Budget for \$150,000 from the Economic Development Set Aside”; and**

3 **WHEREAS, the Sif-Oidak District Council, passed Resolution No. SODC-08-158, “Approving a**
4 **\$150,000 set aside to update the Feasibility Study for the Fuel Station/Convenience**
5 **Store Project and to solicit for three bids to conduct the site preparation”; and**

6 **WHEREAS, the Sif-Oidak District Council, passed Resolution No. SODC-08-159, on October 11,**
7 **2008, “Amending Resolution No. SODC-08-158 to identify funding out of the Economic**
8 **Development Investment Account”; and**

9 **WHEREAS, on December 10, 2012, SODC-11-202 was enacted, “Amending Resolution No. SODC-08-**
10 **159 to include the feasibility studies for the Bob’s Market expenditures”.**


11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O’odham Legislative Council that it does hereby**
12 **approve the Sif-Oidak District Economic Development Budget in the amount of**
13 **\$150,000.**

14 **BE IT FURTHER RESOLVED that the funding will come out of the Sif-Oidak District Economic**
15 **Development Investment Account.**

16 **BE IT FINALLY RESOLVED that in the event there should be any further changes in the funding or**
17 **funding levels that it shall be approved by the Tohono O’odham Legislative Council**
18 **prior to any expenditures.**

19 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 11TH Day**
20 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,182.45 FOR;**
21 **598.15 AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
22 **by Article VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O’odham Nation, adopted by**
23 **the Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**


