RESOLUTION NO. 12-354

1 **WHEREAS, the Ge Oidag Community many years ago had established an account for left over**
2 **funds that had been collected from community members to pay for water supply; and**

3 **WHEREAS, the community requests to close out this account by utilizing the remaining funds and**
4 **any interest it may earn at the time of closure; and**

5 **WHEREAS, the community will apply this funding as a supplement toward the total cost of the**
6 **Watho Renovation at the Feast House in Ge Oidag; and**

7 **WHEREAS, the attached budget and justification has been prepared to reflect the amount of the**
8 **balance as recorded on July 23, 2012 which was a total of \$4,020.93 approved by Ge**
9 **Oidag Community with community Resolution No. GO-90-2012; and**

10 **WHEREAS, Sells District Council did review and approve the FY 2013 Sells District- Ge Oidag Feast**
11 **House Renovation (Water Monies) Budget and it's Justification with Resolution No. SD-**
12 **67-12.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Fiscal**
14 **Year 2013 Sells District - Ge Oidag Feast House Renovation (Water Monies Account)**
15 **Budget and its Justification in the amount of \$4,020.93 and any earned interest to close**
16 **out the Big Field Community account with Morgan Stanley Smith Barney Financial**
17 **Institution.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
19 **District Chairperson and any designated District official to expend and administer the**
20 **budget according to its justification as attached, provided that any**
21 **modifications/amendments affecting the funds or funding levels of the budget shall**
22 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
24 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
