

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District Administration FY2013 Budget Amendment #1)**

RESOLUTION NO. 12-355

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 12-320 approved the Sells District**
2 **Administration Budget in the amount of \$1,202,479.84 from the Tohono O'odham**
3 **Nation's Gaming Revenue; and**

4 **WHEREAS, the original FY2013 budgets approved by Tohono O'odham Legislative did not include**
5 **a budget for the Sells Community due to the fact that the community had not yet**
6 **approved a budget at the requested amount of \$75,000.00 as directed by the**
7 **Administration; and**

8 **WHEREAS, Administration did reserve the \$75,000 for Sells Community by putting that full**
9 **amount into the Reserve for Contingencies line item until the community was ready**
10 **to come forward with a budget in that amount; and**

11 **WHEREAS, Sells District Council, on August 16, 2012 did receive from Sells Community for review**
12 **and approval the attached FY2013 Sells Community Budget and Justification in the**
13 **amount of \$75,000.00; and**

14 **WHEREAS, the \$75,000.00 for Sells Community will be allocated from line item 7800 Reserve for**
15 **Contingencies omitting that line item; and**

16 **WHEREAS, this amendment does not change the overall allocated amount of the FY2013 Budgets**
17 **for Sells District Administration and its Communities which is the amount of**
18 **\$1,202,479.84; and**

19 **WHEREAS, Amendment #1 to the FY2013 Sells District Administration Budget and its Justification**
20 **has been reviewed and approved by Sells District Council with Resolution #SD-78-12.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
22 **the FY 2013 Sells District - Administration Budget Amendment #1 to include the**
23 **FY2013 Sells Community Budget and its Justifications in the amount of \$75,000 as**
24 **attached.**

25 **BE IT FURTHER RESOLVED that this Amendment does not change the overall allocated amount of**
26 **\$1,202,479.84 of the FY2013 Budgets for Sells District Administration and its**
27 **Communities.**




1 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the Sells

3 **according to its justification, as attached, provided that any modifications or**
4 **amendments affecting the funds or funding levels of the budget shall be submitted for**
5 **further prior approval by the Tohono O'odham Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
7 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
9 **VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
10 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**
