**RESOLUTION NO. 12-358**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2012 Arizona Reimbursable**  
2 **Budget: Child Adult Care Food Program 600-12-2036, in the amount of \$85,278.60; and**

3 **WHEREAS, the Child Adult Care Food Program has prepared a budget amendmnet/modification**  
4 **#1 to modify line items and to adjust the indirect cost rate from 16.82% to 15%; and**


5 **WHEREAS, the Human Resources Development Committee and Budget and Finance Committee**  
6 **of the Legislative Council have reviewed this budget and recommends its approval and**  
7 **adoption.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **the FY2012 Child and Adult Care Food Program Budget Amendment/Modification #1**  
10 **by modifying line items and amending the indirect cost rate from 16.82% to 15%.**

11 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
12 **Chairperson and any designated official to expend and administer the budget, as**  
13 **attached, provided that any amendments affecting the funds of funding levels of the**  
14 **budget shall be submitted for further prior approval by the Tohono O'odham**  
15 **Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
17 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
19 **VI, Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**


