(Approving San Lucy District to Continue District Operations and Expenses Pursuant to
Resolution Number 11-500 - Pending Approval of the San Lucy District FY 2013 Budget)**

RESOLUTION NO. 12-367

1 **WHEREAS, pursuant to the Tohono O'odham Nation Constitution Article VI, Section I - (d) 2, 3 the**
2 **Tohono O'odham Council has the fiscal powers to manage funds, and to appropriate**
3 **funds for the benefit of the nation and its members, and to adopt, approve and amend**
4 **annual budgets and to authorize the expenditure of funds...budgets; and**

5 **WHEREAS, the San Lucy District Council by District Resolution Number SL 08-54-12 approved to**
6 **continue district operations and expenses pursuant to the Tohono O'odham**
7 **Legislative Council Resolution Number 11-500 "Approving San Lucy District FY 2012**
8 **Budget" and further request approval by the Tohono O'odham Legislative Council; and**

9 **WHEREAS, the Tohono O'odham Legislative Council, in consideration of the request from the San**
10 **Lucy District Council, have determined that it would be in the best interest of San Lucy**
11 **District and the Nation for San Lucy District to continue district operations.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve San Lucy District request to continue district operations and expenses**
14 **pursuant to Tohono O'odham Legislative Council resolution number 11-500, pending**
15 **approval of the District's FY 2013 Budget.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
17 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
19 **VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
20 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
