3	funds for the benefit of the nation and its members, and to adopt, approve and amend
4	annual budgets and to authorize the expenditure of fundsbudgets; and
5	WHEREAS, the San Lucy District Council by District Resolution Number SL 08-54-12 approved to
6	continue district operations and expenses pursuant to the Tohono O'odham
7	Legislative Council Resolution Number 11-500 "Approving San Lucy District FY 2012
8	Budget" and further request approval by the Tohono O'odham Legislative Council; and
9	WHEREAS, the Tohono O'odham Legislative Council, in consideration of the request from the San
10	Lucy District Council, have determined that it would be in the best interest of San Lucy
11	District and the Nation for San Lucy District to continue district operations.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
13	approve San Lucy District request to continue district operations and expenses
14	pursuant to Tohono O'odham Legislative Council resolution number 11-500, pending
15	approval of the District's FY 2013 Budget.
