7	the projected amount outlined in the attached FY13 budget; and
8	WHEREAS, the proposed budget amount of \$7,146,614.25 was reviewed with, and approved by the
9	citizens of the San Xavier District Community who were present at the August 11, 2012
10	monthly Community meeting; and
11	WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee reviewed the District's
12	FY13 budget on August 23, 2012 and recommended that it be forwarded to the Tohono
13	O'odham Legislative Council for approval.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby with the
15	authority granted under the Tohono O'odham Constitution, Article VI(d)(3) approves
16	the San Xavier District FY13 budget in the amount of \$7,146,614.25 utilizing gaming
17	funds in the amount of \$3,497,205.92 and District funds in the amount of \$3,649,408.33.
