

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 10-342, "Approving the Certification of the Tohono O'odham
Eligible Adult Members Listing for Third Per Capita 47th Approved Listing Payout
Distribution" and 12-147, "Approving the Certification of the Tohono O'odham
Eligible Adult Members Listing for Third Per Capita 66th
Approved Listing Payout Distribution")

RESOLUTION NO. 12-370

1 **WHEREAS, the Enrollment program submitted to the Tohono O'odham Legislative Council the**
2 **certification listing for eligible adult members for review and the Tohono O'odham**
3 **Legislative Council approved the third per capita distribution pursuant to Resolution**
4 **No. 10-342, Approving the Certification of the Tohono O'odham Eligible Adult Members**
5 **Listing for Third Per Capita 47th Approved Listing Payout Distribution" and 12-147,**
6 **"Approving the Certification of the Tohono O'odham Eligible Adult Members Listing**
7 **for Third Per Capita 66th Approved Listing Payout Distribution"; and**

8 **WHEREAS, the Tohono O'odham Nation's Fiduciary Office has identified that two of the members**
9 **listed in the Third Per Capita distribution listings approved by Resolution Nos. 10-342**
10 **and 12-147 were incorrectly listed as adults but were actually minors whose funds are**
11 **held under the Wells Fargo minors trust account; and**

12 **WHEREAS, the Nation's Fiduciary Office recommends that the members be paid the funds**
13 **designated to them as beneficiaries under the Wells Fargo minors trust account; and**

14 **WHEREAS, in order to pay the members from the Wells Fargo trust account, their names must be**
15 **removed from the eligible adult members listings for Third Per Capita payout**
16 **distributions approved by Resolution Nos. 10-342 and 12-147; and**

17 **WHEREAS, the Enrollment Office has verified that each beneficiary has reached the age of**
18 **majority and is no longer restricted from receiving payment of trust benefits; and**

19 **WHEREAS, the Enrollment Office has verified that each beneficiary is listed on the applicable**
20 **master minor listing approved by Legislative Council resolution.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 22 **1. Amends Resolution No. 10-342, "Approving the Certification of the Tohono**
23 **O'odham Eligible Adult Members Listing for Third Per Capita 47th Approved Listing**
24 **Payout Distribution" to remove from the certification listing the name of the**
25 **member identified in the attached Correction to Third Per Capita Distribution**
26 **Listing, which shall not be disclosed;**
- 27 **2. Amends Resolution No. 12-147, "Approving the Certification of the Tohono**
28 **O'odham Eligible Adult Members Listing for Third Per Capita 66th Approved Listing**
29 **Payout Distribution" to remove from the certification listing the name of the**



- 1 member identified in the attached Correction to Third Per Capita Distribution
2 Listing, which shall not be disclosed;
- 3 3. Authorizes Wells Fargo Bank to commence payment to each member who are non-
4 restricted beneficiaries and identified in the attached Correction to Third Per
5 Capita Distribution Listing, subject to the additional requirements of the trust
6 agreement and written confirmation of the beneficiary's current mailing address
7 and other information; and
- 8 4. Authorizes the Chairman of the Nation to execute such other documents as may be
9 necessary to implement this Resolution.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
11 of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
12 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article
13 VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
14 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
16 Stat. 984).
