1 **WHEREAS, the Tohono O'odham Legislative Council approved the Field Supervisor's position for**  
2 **the Water Resources Department FY2012 SAWRSA budget 021-12-4520 through**  
3 **Resolution 12-195; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved the Water Resources Department**  
5 **FY2013 SAWRSA budget 021-13-4520 through Resolution 12-236, in the amount of**  
6 **\$1,810,317.00; and**

7 **WHEREAS, the Water Resources Department is requesting funding for the Field Supervisor's**  
8 **position within the FY2013 SAWRSA budget 021-13-4520 which will increase the FY2013**  
9 **budget 021-13-4520 by \$69,336.59 for a total budget of \$1,879,653.59; and**


10 **WHEREAS, the Water Resources Committee and the Budget and Finance Committee of the**  
11 **Legislative Council have reviewed this Budget and recommend its approval and**  
12 **adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **authorizes the Water Resources Department to add the Field Supervisor's position to**  
15 **the Water Resources Department FY2013 SAWRSA budget 021-13-4520 for a total**  
16 **budget of \$1,879,653.59, in accordance with the budget attached hereto.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
18 **Chairperson and any designated official to expend and administer the Budget, as**  
19 **attached, provided that any Amendments affecting the funds or funding level is**  
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
22 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
24 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
