

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving amendment 1 to the Water Resources Department FY2013 budget  
100-13-4500 to reclassify the Hydrologist's position into the Hydrological  
Advisor, effective October 1, 2012)**

RESOLUTION NO. 12-373

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Water Resources Department**  
2 **FY2013 budget 100-13-4500 through Resolution 12-211, in the amount of \$133,213.21;**  
3 **and**

4 **WHEREAS, the Water Resources Department is requesting an amendment to the FY2013 budget**  
5 **100-13-4500 to reclassify the Hydrologist's position into the Hydrological Advisor;**  
6 **effective October 1, 2012; and**

7 **WHEREAS, amendment 1 will decrease line item 7010 PROGRAM SUPPLIES and increase line**  
8 **items 6000 SALARIES, 6010 LEAVE, 6110 FICA, 6120 WORKERS COMP, and 6240**  
9 **EMPLOYER MATCHING 401K; and**

10 **WHEREAS, the Water Resources Committee and the Budget and Finance Committee of the**  
11 **Legislative Council have reviewed this Budget and recommend its approval and**  
12 **adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **amendment 1 to the Water Resources Department FY2013 budget 100-13-4500 to**  
15 **reclassify the Hydrologist's position into the Hydrological Advisor, effective October**  
16 **1, 2012, in accordance with the budget attached hereto.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
18 **Chairperson and any designated official to expend and administer the Budget, as**  
19 **attached, provided that any Amendments affecting the funds or funding level is**  
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
22 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
24 **VI, Section 1 (d)(3) & 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**


