Grant Budget)

RESOLUTION NO. 12-374

1 **WHEREAS, the Tohono O'odham Legislative Council historically supported the Venito Garcia**
2 **Library, the primary library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library is charged with library development for the Tohono**
4 **O'odham Nation; and**

5 **WHEREAS, the Venito Garcia Library under the Tohono O'odham Nation Education Department**
6 **has applied for and received the Basic Library Services Grant from Institute of**
7 **Museum and Library Services (IMLS), Native American Library Services (NALS) who is**
8 **the primary library funding agency from the United States federal government; and**

9 **WHEREAS, the Venito Garcia Library is submitting an FY 2013 IMLS Basic Grant Budget in the**
10 **amount of \$7,000.00; and**

11 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
12 **Committee of the Tohono O'odham Legislative Council have reviewed this budget and**
13 **recommend its approval and adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **approve and accept the grant funds for the Venito Garcia Library from the Institute of**
16 **Museum and Library Services (IMLS), Native American Library Services (NALS) in the**
17 **amount of \$7,000.00.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does approve the FY 2013**
19 **IMLS Basic Grant Budget in the amount of \$7,000.00.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level is**
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
25 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article**
27 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**






