

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Fiscal Year 2013 Gu-Vo District Budget in the Amount of \$1,929,970.48)**

**RESOLUTION NO. 12-375**

1 **WHEREAS, the Gu-Vo District presented to the Tohono O'odham Legislative Council the District's**  
2 **FY'2013 Budgets for the fiscal year; and**

3 **WHEREAS, Gu-Vo District Governing Council was allocated Gaming Revenue in the amount of**  
4 **\$1,202,479.83; and**

5 **WHEREAS, the amount of \$1,202,479.83 from the Tohono O'odham Nation's Gaming Revenue has**  
6 **been allocated to the communities in the amount of \$42,894.77 per community and**  
7 **the Administration at \$1,030,900.75; and**

8 **WHEREAS, the Gu-Vo District Governing Council at a meeting held on September 17, 2012 with a**  
9 **quorum present, did review and approve the District FY'2013 Budgets in the total**  
10 **amount of \$1,929,970.48; and**

11 **WHEREAS, the following communities and the Administration have been approved to carry over**  
12 **funds into FY'2013**

13 1. **Gu-Vo Community to Carry over FY'2004 (\$1,242.40), FY'2005 (\$8,206.89), FY'2006**  
14 **(\$15,893.32), FY'2007 (\$100,970.78), FY'2009 (\$51,660.00), FY'2010 (\$23,657.71), into**  
15 **FY'2013 budget, the total amount is \$201,631.10.**

16 2. **Ali Chugk Community to Carry over FY'2002 (\$287.76), FY'2003 (\$1,183.79), FY'2004**  
17 **(\$2,191.03), FY'2008 (\$12,137.51), FY'2010 (\$35,181.10) into FY'2013 budget, the**  
18 **total amount is \$50,981.19.**

19 3. **Pia-Oik Community to Carry over FY'1999 (\$39,293.04), FY'2000 (\$9,581.83),**  
20 **FY'2005 (\$1,787.96), FY'2011 (\$110,217.19) into FY'2013 budget, the total amount**  
21 **is \$160,880.02.**

22 4. **Kukatch Community to Carry over FY'1999 (\$57,281.12), FY'2001 (\$35,227.04),**  
23 **FY'2008 (\$20,592.45), FY'2009 (\$487.22) into FY'2013 budget, the total amount is**  
24 **\$113,587.83;**

25 5. **Administration to Carry over FY'1999 (\$200,410.51) into FY'2013 Budget, the total**  
26 **amount is \$200,410.51; and**

27 **WHEREAS, the total budget amount for the Administration and each of the communities as part**  
28 **of the FY'2013 budget are as follows:**

7 **WHEREAS, it is the recommendation of the Tohono O'odham Legislative Budget & Finance**  
8 **Committee to approve the proposed FY'2013 Gu-Vo District Budget.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **approves the Gu-Vo District FY'2013 Budgets submitted by the Four Communities and**  
11 **the Administration in the amount of \$1,929,970.48.**

12 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council has approved for**  
13 **the following Carry overs to be included into the FY'2013 Budgets for the**  
14 **Administration and four Communities:**

- 15 **1. Gu-Vo Community total Carry over into FY'2013 budget is \$201,631.10**
- 16 **2. Ali Chugk Community total Carry over into FY'2013 budget is \$50,981.19**
- 17 **3. Pia-Oik Community total Carry over into FY'2013 budget is \$160,880.02**
- 18 **4. Kukatch Community total Carry over into FY'2013 budget is \$113,587.83**
- 19 **5. Administration total Carry over into FY'2013 budget is \$200,410.51**

20 **BE IT FURTHER RESOLVED the total budget for each of the following communities and**  
21 **Administration FY'2013 District Budget are as follows:**
