

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Carry forward funds from FY-2011 in the amount of \$45,980.46 for the Cooperative Agreement L08AC14165 between the Tohono O'odham Nation and US Bureau of Land Management)**

RESOLUTION NO. 12-377

1 WHEREAS, the Tohono O'odham Nation approved the US Bureau of Land Management  
2 Cooperative Agreement # L08AC14165 to fund undocumented migrant and smuggler  
3 trash clean-up through December 31, 2012 as stated in the Cooperative Agreement;  
4 and

5 WHEREAS, the Grants and Contracts Office has identified a balance from FY-2011 BLM Budget  
6 that needs to be carried forward into a FY-2013 Budget; and

7 WHEREAS, the remaining funds need to be expended by December 31, 2012 when the existing  
8 cooperative agreement #L08AC14165 expires; and

9 WHEREAS, budget has been reviewed by the Agriculture and Natural Resources Committee and  
10 the Budget and Finance Committee of the Legislative Council have reviewed this  
11 budget and recommend its approval and adoption.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and  
13 approves the carry forward amount of \$45,980.46.

14 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the  
15 Chairperson and any designated official to execute the agreements, expend and  
16 administer the budget as attached, provided that any amendments affecting the funds  
17 or funding levels is submitted for further prior approval by the Tohono O'odham  
18 Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day  
20 of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
21 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article  
22 VI, Section 1 (d)(2)(3) & 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the  
23 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
25 18, 1934 (48 Stat. 984).


