2	Waste Management Program Budget 044-12-3525 (formerly 83-0003) through
3	Resolution Nos. 98-236 and 05-558; and
4	WHEREAS, the Solid Waste Management Program has generated in FY-2012 program revenue
5	from residential and commercial trash collection, heavy equipment services and the
6	sale of recycling materials; and
7	WHEREAS, the SWMP prepared a budget in the amount of \$350,000.00 that was approved by
8	Legislative Council Resolution No. 11-353 for the FY2012 budget; and
9	WHEREAS, the SWMP has experienced higher costs due to higher demand for solid waste and
10	heavy equipment services in FY-2012; and
11	WHEREAS, the SWMP prepared a budget amendment #1 to increase the budget from \$350,000.00
12	to \$460,000.00 for the 044-12-3525 budget; and
13	WHEREAS, the SWMP Amended Budget 044-12-3525 has been reviewed and approved by the
14	Legislative Agriculture and Natural Resources Committee and the Legislative Budget
15	and Finance Committee.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
17	the budget amendment #1 to increase the budget from \$350,000.00 to \$460,000.00 for
18	an additional \$110,000.00 from deposits of program revenue for the Solid Waste
19	Management Program FY2012 Budget Account #044-12-3525, from October 1, 2011
20	through September 30, 2012, in accordance with the budget attached hereto.
21	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
22	Chairperson and any designated official to expend and administer the SWMP revenue
23	FY-2012 Budget Account #044-12-3525, provided that any amendments affecting the
24	funds or funding level is submitted for further prior approval by the Tohono O'odham
25	Legislative Council.
26	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20 TH Day
