

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Continuing Resolution for FY 2012 Budgets for the Baboquivari District)

RESOLUTION NO. 12-382

1 **WHEREAS, Baboquivari District Officials have requested a continuing resolution for the FY 2012**
2 **budgets for the District's administration and six communities; and**


3 **WHEREAS, per the Tohono O'odham Nation Accounting Department's weekly expenditure report,**
4 **there are adequate Baboquivari District funds remaining to continue operations until**
5 **the District's FY 2013 budgets are finalized.**

6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**
7 **Baboquivari District administration and six communities are authorized to expend**
8 **Baboquivari District funds in the amounts and for the purposes identified in the**
9 **approved FY 2012 Baboquivari District and community budgets until the FY 2013**
10 **budgets are approved by the Baboquivari District Council and the Legislative Council.**

11 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
12 **Baboquivari District Chairperson and any other designated District official to expend**
13 **and administer the budgets in accordance with the Nation's constitution and laws,**
14 **provided that any modifications/amendments affecting the funds or funding levels of**
15 **the budgets shall be submitted for prior approval by the Tohono O'odham Legislative**
16 **Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
18 **of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
20 **VI, Section 1 (d)(2) and Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,**
21 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
22 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
23 **of June 18, 1934 (48 Stat. 984).**


