12	Baboquivari District Chairperson and any other designated District official to expend
13	and administer the budgets in accordance with the Nation's constitution and laws
	provided that any modifications/amendments affecting the funds or funding levels o

15	the budgets shall be submitted for prior approval by the Tohono O'odham Legislative
16	Council.
