

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2013 Sif-Oidak District Gaming Revenue Budget in the amount
of \$1,202,486.94)

RESOLUTION NO. 12-383

1 WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 12-206, "Approving
2 the FY 2013 District Allocation and Apportionment of Gaming Revenues to Districts by
3 Equal Distribution"; and

4 WHEREAS, the Sif-Oidak District Council, passed Resolution No. SODC 12-104, "Approving the FY
5 2013 Sif-Oidak District Gaming Revenue Budget in the amount of \$1,202,486.94", on
6 Tuesday, August 14, 2012; and

7 WHEREAS, the Legislative Budget and Finance Committee did review the budget on Monday,
8 September 17, 2012 and recommends approval.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does
10 hereby approve the FY 2013 Sif-Oidak District Gaming Revenue Budget in the amount
11 of \$1,202,486.94 for the following:

12 Administration -	\$ 956,822.03
13 Senior Services -	\$ 119,686.98
14 Youth Services -	\$ <u>125,977.94</u>
15 Grand Total	\$1,202,486.94

16 BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding
17 levels that it shall be approved by the Tohono O'odham Legislative Council prior to any
18 expenditures.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day
20 of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
21 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article
22 VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
23 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
25 Stat. 984).
