

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Designating October 12, 2012 from 1:00 p.m. to 6:00 p.m. for a Special Blessing**  
**of Nation's Members Traveling to Rome, Italy for Canonization of the Blessed**  
**Kateri Tekakwitha)**

LEGISLATIVE ORDER NO. 12-385

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and

5 WHEREAS, on February 18, 2012, the Vatican announced seven Blesseds will be canonized on  
6 October 21, 2012, including the first Native American, Kateri Tekakwitha; and

7 WHEREAS, members of the Nation will be traveling to Rome, Italy to witness and participate in  
8 this blessing; and

9 WHEREAS, the Cultural Preservation Committee has recommended that the Legislative Council  
10 designate 1:00 p.m. to 6:00 p.m. during the October 12, 2012 general session for a  
11 special blessing of the Nation's members traveling to Rome for canonization of the  
12 Blessed Kateri Tekakwitha.

13 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the Legislative  
14 Council hereby designates October 12, 2012 general session from 1:00 p.m. to 6:00 p.m.  
15 for a special blessing of the Nation's members traveling to Rome, Italy for  
16 canonization of the Blessed Kateri Tekakwitha.

17 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup> day of  
18 SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,579.90 FOR; -0-  
19 AGAINST; 200.70[01] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council  
20 by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the  
21 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
23 18, 1934 (48 Stat. 984).
