

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 97-144 and 12-301 to Correct Names, Roll  
Numbers, and/or Dates of Birth of Enrollment Applicants and Amending Enrollment  
Resolution No. 93-305 to Delete a Member who was Approved Twice)**

**RESOLUTION NO. 12-387**

- 1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**  
2 **ordinances governing the enrollment and adoption of members (Article II, Section 2**  
3 **and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**
- 4 **WHEREAS, Articles VII and VIII of the Nation's Enrollment Ordinance provide that the Enrollment**  
5 **Committee is responsible for reviewing enrollment applications and making**  
6 **recommendations to the Legislative Council regarding the eligibility of applicants**  
7 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**
- 8 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
9 **applicants for membership contain misspellings in the names of applicants, incorrect**  
10 **roll numbers, and erroneous dates of birth; and**
- 11 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos, 97-144 and 12-**  
12 **301 be amended to reflect the correct name spelling, roll numbers and dates of birth**  
13 **for the individuals identified in the Amending Enrollment Resolutions list, which is**  
14 **incorporated by this reference; and**
- 15 **WHEREAS, the Enrollment Program has determined that a member was erroneously approved**  
16 **twice for membership: originally by Resolution No. 03-90 and again in Resolution No.**  
17 **93-305; and**
- 18 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 93-305 be**  
19 **amended to delete the member identified in the Amending Enrollment Resolutions**  
20 **list, which is incorporated by this reference; and**
- 21 **WHEREAS, the member who was approved in Resolution 03-90 will retain the roll number and**  
22 **approval date identified in that original resolution.**
- 23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
24 **Nos. 97-144 and 12-301 are amended upon the effective date of that resolution to**  
25 **reflect the corrected names, roll numbers and date of birth that are identified in the**  
26 **Amending Enrollment Resolution list.**
- 27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that**  
28 **Resolution No. 93-905 is amended upon effective date of that resolution by deleting the**  
29 **member and corresponding information identified in the Amending Enrollment List.**
