

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 11-158 to Amend the Name of an Enrolled Member)**

RESOLUTION NO. 12-388

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**
2 **ordinances governing the enrollment and adoption of members (Article II, Section 2**
3 **and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**

4 **WHEREAS, Articles X Section 3 of the Nation's Enrollment Ordinance provides that the Tohono**
5 **O'odham Legislative Council "shall cause the membership roll to be kept current**
6 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

7 **WHEREAS, Articles II. Section II of the Nation's Enrollment Ordinance provides that the**
8 **Enrollment Committee is also responsible for keeping the membership roll current**
9 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**


10 **WHEREAS, the Enrollment Committee has received notice of a legal change of name for an**
11 **enrolled tribal member whose enrollment application was approved by Council in**
12 **Resolution No. 11-158; and**

13 **WHEREAS, the Enrollment Committee therefore recommends that the member's name be**
14 **amended accordingly.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the 11-158**
16 **resolution is amended upon the effective date of that resolution to reflect the**
17 **amended name that has been identified in the Amending Enrollment Resolution List.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
19 **of OCTOBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
21 **II, Section 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted**
22 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
