12	Ater Wynne law firm in the amount of \$25,000.00 for FY2013, for the period from
13	October 1, 2012 to September 30, 2013, substantially in the form attached hereto
14	2. Funding for the Attorney Contract will come from the FY 2013 Planning and
15	Economic Development Department Budget.
