**(Approving an Attorney Contract for FY2013 with the Law Firm of Gammage**  
**& Burnham PLC)**

RESOLUTION NO. 12-398

1 **WHEREAS, the Office of Attorney General require the legal services of the law firm of Gammage**  
2 **& Burnham PLC to represent the Tohono O'odham Nation in matters relating to the**  
3 **West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract for fiscal year 2013 for**  
5 **the period from October 1, 2012 to September 30, 2013; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the FY2013 Economic**  
7 **Development budget; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney**  
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**  
12 **law firm of Gammage & Burnham PLC for FY2013, for the period from October 1,**  
13 **2012 to September 30, 2013, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract will come from the FY2013 Economic**  
15 **Development budget.**
- 16 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**  
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
19 **of OCTOBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Article**  
21 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
