

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Attorney Contract for FY2013 with Kerstin G. LeMaire)**

**RESOLUTION NO. 12-400**

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Kerstin G.**  
2 **LeMaire to represent the Tohono O'odham Nation in legal proceedings in Maricopa**  
3 **County, Arizona, involving the Nations interests under the Indian Child Welfare Act;**  
4 **and**

5 **WHEREAS, the Attorney General recommends an Attorney Contract with Kerstin G. LeMaire in the**  
6 **amount of \$35,000.00 for Fiscal Year 2013, for the period October 1, 2012 to September**  
7 **30, 2013; and**

8 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the attorney**  
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**  
12 **Kerstin G. LeMaire in the amount of \$35,000.00 for Fiscal Year 2013, for the period**  
13 **October 1, 2012 to September 30, 2013, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract shall be from the budget of the Office of Attorney**  
15 **General (Account No. 001-13-1030).**
- 16 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**  
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
19 **of OCTOBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
21 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
