6	WHEREAS, the funding for this Attorney Contract will come from the FY 2013 Economic
7	Development Budget; and
8	WHEREAS, the Economic Development Delegation, the Domestic Affairs Committee and the
9	Budget and Finance Committee have reviewed this attorney contract and recommend
10	approval by the Legislative Council.
11	NOW, THEREFORE, BE IT RESOLVED THAT:
12	1. The Tohono O'odham Legislative Council approves the Attorney Contract with the
13	law firm of SNR Denton US LLP or FY 2013, for the period from October 1, 2012 to
14	September 30, 2013, substantially in the form attached hereto.
15	2. Funding for the Attorney Contract will come from the FY 2013 Economic
16	Development Budget.
17	3. The Chairperson of the Nation is authorized and directed to execute the Attorney
