3	to the Nation's water, including implementation of the Nation's Water Code,
4	implementation of SAWRSA, water settlements, and other related matters as assigned
5	by the Attorney General; and

	WHEREAS, funding for the attorney contract will be from the SAWRSA Trust Fund, account
7	number 021-13-1033; and
8	WHEREAS, the Domestic Affairs, Water Resources and Budget & Finance Committees have
9	reviewed the attorney contract and recommend approval by the Legislative Council.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
11	1. Approves the Attorney Contract with Steven Weatherspoon, PLLC, in the amount
12	of \$150,000.00 for the period October 1, 2012 to September 30, 2013, substantially
13	in the form attached hereto.
14	2. Funding for the Attorney Contract shall be from the SAWRSA trust fund, account
15	number 021-13-1033.
16	3. The Chairperson of the Nation is authorized and directed to execute the Attorney
17	Contract.
