10	contract and recommend approval by the Legislative Council.

12	1. The Tohono O'odham Legislative Council approves the Attorney Contract with the
13	law firm of Yoder & Langford in the amount of \$30,000.00 for FY 2013, for the period
14	from October 1, 2012 to September 30, 2013, substantially in the form attached
15	hereto.
16	2. Funding for the Attorney Contract shall be provided from the budget of the Office
17	of Attorney General (001-13-1030).
18	3. The Chairperson of the Nation is authorized and directed to execute the Attorne
