(Approval of Amendment No. 1 for the U.S. Department of Justice, Community Oriented Policing Services, Hiring Recovery Grant Program revising total project costs; Approval of Five Month Extension to December 31, 2012, and Approving the FY 2012 Budget for Year Three in the amount of \$206,937.90)

RESOLUTION NO. 12-408

1 **WHEREAS, the Tohono O'odham Nation (TON) received and accepted a three year grant award**
2 **from the U.S. Department of Justice, Community Oriented Policing Services Hiring**
3 **Recovery Program (CHRP) for the hiring of three entry-level police officers, through**
4 **TOLC Resolution No. 09-587; and**

5 **WHEREAS, this grant expires on June 30, 2012, however a grant extension has been requested and**
6 **approved to extend the performance period to December 31, 2012 to fulfill the grants**
7 **requirements performance period of 36 months; and**

8 **WHEREAS, TOLC Resolution No. 12-560, approved the Tohono O'odham Nation Executive, Judicial,**
9 **and Legislative Tri-Branch FY 2012 Tohono O'odham Nation Pay Plan effective October**
10 **1, 2011, and therefore grant funded programs were directed to obtain approval from**
11 **the funding agency to increase salaries; and**

12 **WHEREAS, upon recalculation of budget amounts in preparing the Budget Modification, a**
13 **decrease in federal funds was determined revising the total project costs of federal**
14 **funding; and**

15 **WHEREAS, the attached FY 2012-2013 budget for year three has been created for the budget**
16 **period covering January 1, 2012 through December 31, 2012 and has been reviewed by**
17 **the Budget Office, Grants & Contracts, Executive Office, Domestic Affairs Committee**
18 **and Budget & Finance Committee of the Legislative Council and recommends**
19 **approval; and**

20 **WHEREAS, the grant does not allow Indirect Cost.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **approves the attached FY 2012-2013 budget in the amount of \$207,245.64 for year three**
23 **covering the period of January 1, 2012 through December 31, 2012 and waiving of**
24 **Indirect Cost.**

25 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby accepts and**
26 **approves the No Cost Extension of the grant period to December 31, 2012.**


