7	WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget for the FY 2013
8	budget year, which has been reviewed by the Budget Office, Grants & Contracts,
9	Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of all
10	which recommend acceptance by the Tohono O'odham Legislative Council.
11	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
12	approves the FY 2013 budget for the DOJ/OJP/OJJP Youth Mentoring Grant in the
13	amount of \$159,729.73.
14	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
15	Chairman and any designated official to expend and administer the budget as
16	attached, provided that any amendments affecting the funds or funding level shall be
17	submitted for further prior approval by the Tohono O'odham Legislative Council.
