

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2013 budget for the Department of Justice, Office of Justice
Programs, Office of Juvenile Justice and Delinquency Prevention, Youth
Mentoring Program Grant no. 2011-TY-FX-0010)**

RESOLUTION NO. 12-410

1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded the Department of Justice**
2 **(DOJ) Office of Justice (OJP) office of Juvenile Justice and Delinquency Prevention**
3 **(OJJDP) Youth Mentoring Program (YMP) grant; and**

4 **WHEREAS, the Tohono O'odham Legislative Council (TOLC) enacted TOLC Resolution No. 11-541**
5 **accepting the YMP grant award; and**

6 **WHEREAS, this grant is effective October 1, 2011 through September 30, 2014; and**

7 **WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget for the FY 2013**
8 **budget year, which has been reviewed by the Budget Office, Grants & Contracts,**
9 **Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of all**
10 **which recommend acceptance by the Tohono O'odham Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves the FY 2013 budget for the DOJ/OJP/OJJP Youth Mentoring Grant in the**
13 **amount of \$159,729.73.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
15 **Chairman and any designated official to expend and administer the budget as**
16 **attached, provided that any amendments affecting the funds or funding level shall be**
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
19 **of OCTOBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**




