

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Commerce Committee to hold a Hearing on the Application of Liquor License
filed by the Tohono O'odham Gaming Enterprise)

LEGISLATIVE ORDER NO. 12-414

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Legislative Council,**
3 **standing committees, boards and special committees and to prescribe the duties and**
4 **powers of all Legislative Council committees (Constitution of the Tohono O'odham**
5 **Nation, Article VI, Section 1(a) and (b)); and**

6 **WHEREAS, the Legislative Council has vested the Commerce Committee with oversight authority**
7 **over all gaming-related matters (Plan of Operation for Commerce Committee, Article**
8 **III.C.3.a.); and**

9 **WHEREAS, the Tohono O'odham Gaming Enterprise ("TOGE") has filed a liquor license**
10 **application with the Arizona Department of Liquor Licenses and Control for a Series**
11 **10 Beer and Wine Store license for the Desert Diamond Casino located at Highway 86,**
12 **Mile Post 55, Why, Arizona; and**

13 **WHEREAS, pursuant to Arizona law, the Nation as the local governing body is required to hold a**
14 **hearing on the liquor license application and recommend approval or disapproval to**
15 **the Department of Liquor Licenses and Control (A.R.S. § 4-201(B) and (C)); and**

16 **WHEREAS, it is in the best interest of the Nation to authorize and empower the Commerce**
17 **Committee to conduct the hearing and issue a recommendation on the liquor license**
18 **application filed by TOGE.**

19 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
20 **authorizes and empowers the Commerce Committee to**

- 21 **1. conduct a hearing on the Application for a Series 10 Beer and Wine Store Liquor**
22 **License filed with the Arizona Department of Liquor Licenses and Control by the**
23 **Tohono O'odham Gaming Enterprise for the Desert Diamond Casino located at**
24 **Highway 86, Mile Post 55, Why, Arizona; and**
- 25 **2. enter an order recommending approval or disapproval of the liquor license**
26 **application within sixty days after filing of the application; and**
- 27 **3. file a certified copy of the Committee's recommendation with the director of the**
28 **Department of Liquor Licenses and Control.**

29 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05TH day of**
30 **NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
31 **AGAINST; [02] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(a) and (b) of the Constitution of the Tohono O'odham Nation, adopted by the**
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat. 984).**


