

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Endorsing General Election 2012 Candidates for Federal, State, and Local Offices)**

**RESOLUTION NO. 12-417**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**  
2 **authority to "consult, negotiate and conclude agreements and contracts on behalf of**  
3 **the Tohono O'odham Nation with federal, state and local governments" and to**  
4 **"promote, protect and provide for public health, peace, morals, education and general**  
5 **welfare of the Tohono O'odham Nation and its members" (Constitution, Article VI,**  
6 **Section 1, (f),(c)(2)); and**

7 **WHEREAS, in November 2012, the State of Arizona will hold a general election for representatives**  
8 **to the United States House of Representatives, the United States Senate, Arizona state**  
9 **senators and representatives, county supervisors, and the President of the United**  
10 **States; and**

11 **WHEREAS, the Tohono O'odham Nation consults with the federal government on a wide variety**  
12 **of issues that affect the Nation's members; and**

13 **WHEREAS, state and local government legislation and policies also impact the Nation and its**  
14 **members; and**

15 **WHEREAS, although the Nation encourages its members to vote as they deem appropriate, it is**  
16 **in the Nation's best interest to identify qualified federal, state, and local candidates**  
17 **for office most closely aligned with the Nation's objectives; and**

18 **WHEREAS, the Appropriations Committee recommends endorsing candidates for federal, state,**  
19 **and local office.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
21 **endorses and supports the following candidates for office:**

- 23 **2. Richard Carmona for United States Senate**
- 24 **3. Krysten Sinema for U.S. House of Representatives Congressional District 9**
- 25 **4. Raul Grijalva for U.S. House of Representatives Congressional District 3**

- 27 **6. Linda Lopez for Arizona Senate District 2**
- 28 **7. Andrea D'Alessandro for Arizona House District 2**






