5	Convention in Sacramento, California from October 21 - 26, 2012; and
6	WHEREAS,the Tohono O'odham Nation has worked closely with the NCAI and with Indian tribes
7	across the United States to address numerous national issues of importance to Indian
8	people; and
9	WHEREAS, it is in the best interest of the Tohono O'odham Nation to continue its national-level
10	involvement in these issues by participating in the NCAI 2012 Annual Convention.
11	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
12	authorizes Chairman Ned Norris, Jr. to serve as the Nation's voting delegate and
13	Legislative Chairman Timothy Joaquin to serve as the Nation's alternate voting
14	delegate to the NCAI 2012 69 th Annual Convention; provided that the voting delegate,
15	alternate, and any Legislative Council representatives attending the NCAI Annual
16	Convention are authorized to present and advocate for resolutions and positions
17	previously approved by the Tohono O'odham Legislative Council.
