

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating funds for payment of 2012 Maricopa County property taxes)

RESOLUTION NO. 12-422

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to administer land**
2 **and "to manage any funds within the exclusive control of the Tohono O'odham Nation,**
3 **including proceeds derived from lands and resources of the Tohono O'odham Nation,**
4 **and to appropriate these funds for the benefit of the nation and its members. All**
5 **expenditures of these funds shall be pursuant to appropriations or budgets**
6 **authorized under resolutions or in accordance with ordinances of the Tohono**
7 **O'odham Council . . ." (Constitution of the Tohono O'odham Nation, Article VI, Section**
8 **1(d)(2)) and 1(i); and**

9 **WHEREAS, in 1986 the United States Congress enacted the Gila Bend Indian Reservation Lands**
10 **Replacement Act, Pub. L. 99-503 (the "Act"), and appropriated funds to the Nation to**
11 **expend on behalf of the San Lucy District for land and water rights acquisition,**
12 **economic and community development, and relocation costs; and**

13 **WHEREAS, the Nation has acquired approximately 135 acres of land in Maricopa County (the**
14 **"Settlement Property") pursuant to the Act, which Settlement Property is currently**
15 **awaiting acquisition in trust by the United States; and**

16 **WHEREAS, 2012 Maricopa County property taxes have been assessed on the Settlement Property,**
17 **the first half of which are due and payable; and**

18 **WHEREAS, the Tohono O'odham Legislative Council Economic Development Delegation, the**
19 **Commerce Committee, and the Budget and Finance Committee, recommend**
20 **appropriation of \$43,567.96 from Pub. L. 99-503 funds for payment of the 2012**
21 **Maricopa County property taxes assessed on the Settlement Property.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
23 **appropriates \$43,567.96 from Pub. L. 99-503 funds for payment of the 2012 Maricopa**
24 **County property taxes assessed on the Settlement Property.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs the**
26 **Treasurer, with the advice of the Office of Attorney General, to timely make all 2012**
27 **Maricopa County tax payments assessed on the Settlement Property.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
29 **of OCTOBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
31 **VI, Section 1 (d)(2) and (i) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**






