

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2013 Administrative Lobby Budget Amendment No. 1)

RESOLUTION NO. 12-424

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Council has approved the FY 2013 Administrative Lobby budget, and,**
7 **in response to the upcoming federal, state, and local elections, the Nation's Chairman**
8 **is recommending that the budget be amended to authorize expenditures to promote**
9 **voting by tribal members; and**

10 **WHEREAS, the Executive Branch administration has accordingly prepared and submitted for**
11 **review and approval the FY 2013 Administrative Lobby Budget Amendment No. 1,**
12 **which amends the budget justification for line item 7340 Public Relations; and**

13 **WHEREAS, the budget amendment does not change the amount of funds budgeted for FY 2013;**
14 **and**

15 **WHEREAS, the FY 2013 Administrative Lobby Budget Amendment No. 1 has been reviewed by the**
16 **Appropriations and Budget and Finance Committees.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby approves the FY 2013**
18 **Administrative Lobby Budget Amendment No. 1 to amend the budget justification for**
19 **line item 7340 Public Relations to permit expenditures to promote voting by tribal**
20 **members.**

21 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Chairperson and**
22 **any designated official are authorized to administer the attached budget, provided**
23 **however, that any amendments affecting these funds or funding levels budgeted shall**
24 **be submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
26 **of OCTOBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
28 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
