

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution Nos. 23-81, 436-87, 94-504, 95-003, 97-221, 98-429,**  
**2000-298, 01-183 and 04-109 to Correct Names of Enrollment Applicants and**  
**Amending Enrollment Resolution Nos. 98-206 and 10-337 to Delete**  
**Members who were Approved Twice)**

**RESOLUTION NO. 12-426**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**  
2 **ordinances governing the enrollment and adoption of members (Article II, Section 2**  
3 **and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**

4 **WHEREAS, Articles VII and VIII of the Nation's Enrollment Ordinance provide that the Enrollment**  
5 **Committee is responsible for reviewing enrollment applications and making**  
6 **recommendations to the Legislative Council regarding the eligibility of applicants**  
7 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

8 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
9 **applicants for membership contain misspellings in the names of applicants; and**

10 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 23-81, 436-87,**  
11 **94-504, 95-003, 97-221, 98-429, 2000-298, 01-183 and 04-109 be amended to reflect the**  
12 **correct name spelling for the individuals identified in the Amending Enrollment**  
13 **Resolution List November 2012, which is incorporated by this reference; and**

14 **WHEREAS, the Enrollment Program has determined that three members were erroneously**  
15 **approved twice for membership whereby originally two members were originally**  
16 **approved by Resolution No. 97-221 and one member originally approved by Resolution**  
17 **No. 98-034; and**

18 **WHEREAS, the Enrollment Program discovered that these same three members were approved**  
19 **a second time in Resolution Nos. 98-206 and 10-337; and**

20 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 98-206 and 10-**  
21 **337 be amended to delete the members identified in the Amending Enrollment**  
22 **Resolution List November 2012; and**

23 **WHEREAS, the members who were approved in Resolution Nos. 97-221 and 98-034 will retain the**  
24 **roll numbers and approval dates identified in those original resolutions.**


25 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**

4 Amending Enrollment Resolution List November 2012.


5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day

9 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
10 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
11 18, 1934 (48 Stat. 984).
