9	WHEREAS,	the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per
10		capita distribution per Legislative Council Resolution No. 09-164; and
11	WHEREAS,	the Chairman of the Nation received written notification from the Department of the
12	:	Interior on June 15, 2009 that the Nation's Revenue Allocation Plan is approved; and
13	WHEREAS,	the Nation's Department of Membership Services, Enrollment Program submits to the
14	,	Tohono O'odham Legislative Council the certification Listing for eligible adult
15		members for review and approval for a fourth per capita distribution; and
16	WHEREAS.	pursuant to Resolution No. 09-428 which approved the Master List for certification,
17	,	the initial number of verified adult eligible members for the fourth per capita
18		distribution is 19,141; and
19	WHEREAS.	the disbursement of funds to each eligible adult member is contingent upon
20		verification of a member and further certification by the Tohono O'odham Legislative
21		Council.
