10		recommends that Triadvocates, LLC be retained as a governmental relations
11		consultant for matters involving State of Arizona legislative, administrative,
12		appropriations, lobbying, and agency activities, as well as State of Arizona local and
13		municipal governmental activities, that may affect the Nation in accordance with the
14		attached Governmental Relations Representation Contract with Triadvocates, LLC
15		("Contract") for the period commencing October 1, 2012 and ending September 30,
16		2013.
17	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:

- 1. Approves the Contract with Triadvocates, LLC in the amount of \$180,000 for the period commencing October 1, 2012 and ending September 30, 2013 in substantially the form attached hereto; provided that the Contract shall be funded from the FY 2013 Executive Branch Administrative Lobby Budget, line item 7335 -Lobbying; and
- 2. Authorizes the Nation's Chairperson to execute the Contract.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>05TH</u> Day of NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-AGAINST: -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI. Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
