1 **WHEREAS, the Tohono O'odham Nation was awarded the Department of Justice, Tohono O'odham**
2 **Nation Project Safe Neighborhoods Initiative Grant #2011-GP-BX-0030; and**

3 **WHEREAS, the Department of Justice, Office of Justice Program, Tohono O'odham Nation Project**
4 **Safe Neighborhoods Initiatives, Grant # 2011-GP-BX-0030 has a remaining balance of**
5 **\$118,234.10; and**

6 **WHEREAS, the Department of Justice, Office of Justice Programs, Tohono O'odham Nation Project**
7 **Safe Neighborhoods Initiative carry forward funds has been reviewed by the Budget**
8 **Office, Office of Grants & Contracts, Executive Office, Domestic Affairs Committee and**
9 **Budget & Finance Committee, of which all recommend acceptance of the grant**
10 **amendment by the Legislative Council; and**

11 **WHEREAS, this grant does not allow Indirect Cost.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
13 **FY 2013 carry forward Budget of the Department of Justice Programs Tohono O'odham**
14 **Nation Project Safe Neighborhoods Initiative Grant #2011-GP-BX-0030, in accordance**
15 **with the terms of the grant award period of 07/01/11 to 06/30/13 and to utilize the**
16 **Nation's resources pending reimbursement from Grantor for the continuation of**
17 **grant.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the Budget as**
20 **attached, provided that any Amendments affecting the funds or funding level is**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
23 **of NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
25 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**


