

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of an FY 2013 Asset Forfeiture Program budget under the U. S. Department
of Justice Asset Forfeiture Funds for the Tohono O'odham Nation Police Department)**

RESOLUTION NO. 12-443

1 WHEREAS, pursuant to the Tohono O'odham Legislative Council Resolution No. 01-128, 03-085
2 and 04-429 concerning use of the Asset Forfeiture Funds; and

3 WHEREAS, the Tohono O'odham Nation Police Department is requesting for the authorization to
4 expend the funds under the U.S. Department of Justice Asset Forfeiture Funds account;
5 and


6 WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget which has been
7 reviewed by the Budget Office, Executive Office, Domestic Affairs Committee and
8 Budget & Finance Committee, of all which recommend acceptance by the Tohono
9 O'odham Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
11 approves and authorizes the use of Asset Forfeiture Funds under the U. S. Department
12 of Justice Asset Forfeiture Funds Program in the amount of \$182,000.00.

13 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
14 Chairman and any designated official to expend and administer the budget as
15 attached, provided that any amendments affecting the funds or funding level shall be
16 submitted for further prior approval by the Tohono O'odham Legislative Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day
18 of NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
19 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article
20 VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
21 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).


