

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Amended Department of Justice, Office of Justice Programs, Bureau  
of Justice Assistance, Tohono O'odham Nation Resource Center #2011-IP-BX-0001  
for \$350,004.00 and approval of year two FY 2013 budget amount of \$167,266.99)**

**RESOLUTION NO. 12-444**

1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded the Department of Justice,**  
2 **Office of Justice Programs, Bureau of Justice Assistance, Tohono O'odham Resource**  
3 **Center Grant No. #2011-IP-BX-0001 in the amount of \$350,004.00 for a three year grant**  
4 **from October 1, 2011 through September 30, 2014; and**

5 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) Corrections Program has**  
6 **created a FY 2013 second year budget; and**

7 **WHEREAS, the TONPD Corrections Program has requested and was approved for an adjustment**  
8 **to the amended DOJ grant funds for salaries increases for the Resource Center**  
9 **Program; and**

10 **WHEREAS, this grant and budget has been reviewed by the Budget Office, Office of Grants &**  
11 **Contracts, Executive Office, Domestic Affairs Committee and Budget & Finance**  
12 **Committee, of which all recommend acceptance of the grant amendment by the**  
13 **Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
15 **accepts the adjusted amended DOJ grant funds and the FY 2013 Budget totaling**  
16 **\$167,266.99 for the Tohono O'odham Nation Resource Center Grant #2011-IP-BX-0001**  
17 **on a reimbursement basis from the Tohono O'odham Nation General Fund.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and authorizes**  
19 **TONPD Corrections Program to expend funds from the Department of Justice, Office**  
20 **of Justice Programs, Bureau of Justice Assistance, Tohono O'odham Nation Resource**  
21 **Center Grant #2011-IP-BX-0001 in accordance with the terms of the grant award**  
22 **period of 10/01/12 to 09/30/13.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the Budget as**  
25 **attached, provided that any Amendments affecting the funds or funding level is**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
28 **of NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
29 **AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**
