1	WHEREAS, the Tohono O'odham Nation entered into an intergovernmental agreement called an
2	Emergency Dispatch Services Agreement with the Drexel Heights Fire District on or
3	about August 16, 2002, and it has been extended annually; and
4	WHEREAS, under the Emergency dispatch Services Agreement, the Drexel Heights Fire District
5	provides emergency dispatch services to the Tohono O'odham Nation Fire Department
6	for the Nation's San Xavier District at an agreed price per dispatched call; and
7	WHEREAS, the parties have agreed to continue the mutually beneficial arrangement for an
8	additional year at the price of \$30.25 per dispatched call, increased from \$27.50 per
9	dispatched call, and to execute a new Emergency Dispatch Services Agreement; and
10	WHEREAS, the agreement shall be in effect for the time period October 1, 2012 to September 30,
11	2013; and
12	WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have
13	reviewed the proposed agreement and recommend approval by the Legislative
14	Council.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
16	Emergency Dispatch Services Agreement with the Drexel Heights Fire District
17	substantially in the form attached hereto and authorizes the Chairman of the Tohono
18	O'odham Nation to execute it and any further amendments extending the term of the
19	agreement.
