14		Development Delegation Budget; and

17	WHEREAS,	a federal lobbying contract, including an Exhibit A FY 2013 Billing Rates Schedule and

20		LLP ("the Attorneys") and has been reviewed by the Legislative Appropriations,
21		Domestic Affairs, and Budget and Finance Committees.
