

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2013 Budgets for Baboquivari District Administration and the Six
Communities of Artesia/Little Tucson, Choulic, Coldfields, Fresnal Canyon, South
Komelic and Topawa)**

RESOLUTION NO. 12-452

1 **WHEREAS, at a session of the Tohono O'odham Legislative Council, held on November 6, 2012; and**
 2 **WHEREAS, Baboquivari District Officials presented their FY 2013 budgets for Administration and**
 3 **the six communities of Artesia/Little Tucson, Choulic, Coldfields, Fresnal Canyon,**
 4 **South Komelic and Topawa; and**
 5 **WHEREAS, per Resolution No. 12-206 of the Tohono O'odham Legislative Council, gaming**
 6 **revenues for FY 2013 were allocated to the 11 districts by equal distribution; and**
 7 **WHEREAS, the Baboquivari District was allocated \$1,202,479.84; and**
 8 **WHEREAS, utilizing a 40%/60% formula, Baboquivari District Administration was allocated**
 9 **\$480,991.96 @ 40%; and**
 10 **WHEREAS, utilizing a 40%/60% formula, the six communities were allocated \$120,247.98 per**
 11 **community; and**
 12 **WHEREAS, per the following breakdown, the amounts of gaming revenues, mining royalties and**
 13 **saving dollars have been approved for the following:**

2 **Administration, and \$185,772.36 for Topawa shall be utilized at later dates.**


3 **BE IT FINALLY RESOLVED** that any modifications, amendments or changes in the justifications

9 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
10 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**


