	WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council
11	of a Conflict Attorney Contract with Belinda B. BreMiller on such terms.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
13	Conflict Attorney Contract for Belinda B. BreMiller in substantially the form attached
14	hereto in an amount not to exceed \$60,000.

16	shall end September 30, 2013.
