6	the authority to "by majority vote, call for a special session" (Legislative Rules of the						
7	Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and						
8	WHEREAS, the Rules Committee has requested a special session on November 26, 2012 for						
9	Election Ordinance amendments.						
10	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a						
11	special session on November 26, 2012 for Election Ordinance amendments.
