

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the Sells District Council Appointment of Maria Ackerman as Alternate to
Legislative Representative Evelyn Juan Manuel)**

LEGISLATIVE ORDER NO. 12-461

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
2 **“enact laws and ordinances for conducting and regulating elections” and provides**
3 **that the “decision of the Tohono O'odham Council in all election matters, including**
4 **the eligibility and qualifications of candidates, shall be final” (Constitution, Article VI,**
5 **Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, during the May 2009 general election Evelyn Juan Manuel was elected as Legislative**
7 **Council representative for the Sells District but the alternate representative seat**
8 **remained vacant; and**


9 **WHEREAS, on November 15, 2012, the Sells District Council appointed Maria Ackerman to serve**
10 **as Representative Evelyn Juan Manuel's alternate on the Legislative Council (Sells**
11 **District Council Resolution No. SD-99-12); and**

12 **WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented**
13 **on the Legislative Council, has recognized district council appointments to vacant**
14 **alternate seats in instances where vacancies have occurred outside of provisions**
15 **expressly outlined in the Uniform Election Ordinance for filling vacancies.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it recognizes**
17 **the Sells District Council appointment of Maria Ackerman to serve as alternate to**
18 **Legislative Council Representative Evelyn Juan Manuel when Representative Evelyn**
19 **Juan Manuel is unable to attend a Legislative Council session.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 19TH day of**
21 **NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,594.30 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 186.30[02] ABSENT, pursuant to the powers vested in the Council**
23 **by Article VI, Section 1 (g); Article X, Section 7; and Article XII, Section 1 of the Constitution of the**
24 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
25 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
26 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
