

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Extension of Grant Agreement No. 04-11-NA-761d thru December 31, 2012
with the United States Department of the Interior-National Park Service)

RESOLUTION NO. 12-463

1 WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 11-528 in the amount
2 of \$84,824.00 for FY 2012 to fund the operations of the Tribal Historic Preservation
3 Office from National Park Service Grant No. 04-11-NA-761d; and

4 WHEREAS, the National Park Service Tribal Preservation Program notified all THPOs on October
5 15, 2012 that the FY 2012 Budget Expenditures would be extended to December 31,
6 2012; and

7 WHEREAS, the Legislative Cultural Preservation Committee and the Budget and Finance
8 Committee have reviewed and approved this FY 2012 budget extension.

9 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby approves the extension of
10 the FY 2012 Tribal Historic Preservation Office Budget (Grant Agreement No. 04-11-NA-
11 761d), in substantially the form attached hereto, in the amount of \$24,952.20 as an
12 extension of the FY 2012 Budget to December 31, 2012.

13 BE FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
14 Chairperson and any designated official to expend and administer the budget as
15 attached, provided that any amendments affecting the funds or funding level is
16 submitted for further prior approval by the Tohono O'odham Legislative Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day
18 of NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
19 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
20 Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
21 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).


