

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving San Lucy District FY 2013 Budget)**

RESOLUTION NO. 12-465

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to authority of the Tohono**  
2 **O'odham Constitution has exclusive powers over the management of Nation's funds**  
3 **and to appropriate these funds for the benefit of the Nation and its members; and**

4 **WHEREAS, annually, funds from gaming revenues are apportioned to each district for budgetary**  
5 **purposes and on June 25, 2012 the Tohono O'odham Legislative Council approved**  
6 **equal distribution of Gaming Revenues to each district in the amount of \$1,202,479.84;**  
7 **and**

8 **WHEREAS, the San Lucy District Council have prepared the FY 2013 district budget and have**  
9 **presented the budget to community members on September 19, 2012 and by**  
10 **Resolution No. SL 09-66-12 the San Lucy District Council approved the San Lucy District**  
11 **FY 2013 Budget; and**


12 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance committee have**  
13 **reviewed the San Lucy District FY 2013 budget and agreed to forward the budget to the**  
14 **legislative council for consideration.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **the San Lucy District FY 2013 Budget in the amount of \$2,234,016.34, and said budget**  
17 **approval shall be retro-active to October 1, 2012 and end September 30, 2013.**

18 **BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby appropriates**  
19 **\$1,202,479.84 from Gaming Revenues; interest of \$228,599.00 from various San Lucy**  
20 **District Accounts; and \$802,937.50 from P.L. 99-503 to fund the FY 2013 San Lucy**  
21 **District Budget.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
23 **of NOVEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**  
26 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**
