(Designating December 4, 2012 General Session to Tour the Proposed Rosemont Mine Site)

LEGISLATIVE ORDER NO. 12-466

1	WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2	regulate all meetings of the Tohono O'odham Council, standing committees, boards
3	and special committees." (Constitution of the Tohono O'odham Nation, Article VI,
4	Section 1(a)); and
5	WHEREAS, Article I, Section 2.,(C) of the Legislative Rules of the Tohono O'odham Legislative
6	Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at
7	the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham
8	Nation, with the following exceptions [a] majority of all the legislative
9	representatives may vote to hold a session in some location other than the chambers
10	located at Sells."; and
11	WHEREAS, the Cultural Preservation  Committee has requested the Legislative Council designate
12	the December 4, 2012 general session to tour the proposed Rosemont Mine Site with
