

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution Nos. 95-051, 95-192, 96-260, 97-005, 97-105, 98-034, 99-200, 05-426 and 11-459 to Correct Names and Roll Numbers of Enrollment Applicants)**

RESOLUTION NO. 12-472

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and  
2 ordinances governing the enrollment and adoption of members (Article II, Section 2  
3 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation); and

4 WHEREAS, Articles VII and VIII of the Nation's Enrollment Ordinance provide that the Enrollment  
5 Committee is responsible for reviewing enrollment applications and making  
6 recommendations to the Legislative Council regarding the eligibility of applicants  
7 (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

8 WHEREAS, the Enrollment Program has determined that a number of resolutions approving  
9 applicants for membership contain misspellings in the names of applicants and  
10 incorrect roll numbers; and

11 WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 95-051, 95-192,  
12 96-260, 97-005, 97-105, 98-034, 99-200, 05-426 and 11-459 be amended to reflect the  
13 correct name spelling and roll numbers for the individuals identified in the Amending  
14 Enrollment Resolutions list, which is incorporated by this reference.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution  
16 Nos. 95-051, 95-192, 96-260, 97-005, 97-105, 98-034, 99-200, 05-426 and 11-459 are  
17 amended upon the effective date of that resolution to reflect the corrected names, and  
18 roll numbers that are identified in the Amending Enrollment Resolution list.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> Day  
20 of DECEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
21 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article  
22 II, Section 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation,  
23 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
24 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
25 of June 18, 1934 (48 Stat. 984).
